1 Introduction

syngo.share provides both HL7 v2 and HL7 FHIR interfaces for communicating and synchronizing with third-party systems within healthcare settings (henceforth referred to as HL7 and FHIR, respectively).

The *syngo.share* HL7 interface is designed according to the following specifications:

- HL7 Messaging Standard version 2.8.1
- IHE IT Infrastructure Technical Framework revision 11.0
- IHE Radiology Technical Framework revision 13.0

The *syngo.share* FHIR interface is designed according to the following specifications:

- FHIR Standard version 4.1.0

This Conformance Statement addresses all requirements and particularities of the *syngo.share* HL7 and FHIR interfaces which need to be taken into account in order to establish a successful exchange of data with third-party systems. It provides information about the HL7 communication, the HL7 message syntax, the HL7 inbound and outbound interfaces of *syngo.share*, as well as the layout of the supported HL7 messages and how they are processed or generated.

This Conformance Statement likewise provides information on the FHIR features supported by *syngo.share*, the supported published and proprietary FHIR extensions, as well as *syngo.share*-specific FHIR profiles.

Moreover, this Conformance Statement provides example workflows in which certain HL7 messages and FHIR interactions may occur in order to help contextualize the presented information.

2 HL7 General Information

The *syngo.share* HL7 interface is designed according to the HL7 Messaging Standard (version 2.8.1) as well as the IHE IT Infrastructure Technical Framework (revision 11.0) and IHE Radiology Technical Framework (revision 13.0). The primary purpose of the *syngo.share* HL7 interface is the synchronization with third-party systems within healthcare settings. To achieve this goal, *syngo.share* is able to receive and process various kinds of HL7 messages. *syngo.share* also provides the means to generate and send HL7 messages in order to inform third-party system about changes.

Note that HL7 segments, fields, components, and subcomponents which are not mentioned in the following chapters are ignored and hence not evaluated by *syngo.share*.

The HL7 Messaging Standard strictly differentiates between the insertion and update of information. However, since it is generally inconvenient or impossible for systems to decide whether information has to be inserted or updated, *syngo.share* treats HL7 messages which insert or update information depending on the existence of the underlying objects (e.g. patients, visits, orders). This means that if *syngo.share* receives an HL7 message to insert an object which already exists, the information of the object is updated. Conversely, if *syngo.share* receives an HL7 message to update the information of an unknown object, the corresponding object is inserted.

Abbreviations and Notation

This document uses the following abbreviations to indicate the mandatoriness of HL7 segments, fields components and subcomponents:

- **R:** required
- **C:** conditionally required
- **O:** optional

For outgoing HL7 messages, R indicates that a given HL7 segment, field, component, or subcomponent is always specified by *syngo.share*. C and O indicate that a given HL7 segment, field, component, or subcomponent is merely specified under certain circumstances or when *syngo.share* possesses the corresponding information.

Length Information

For some of the listed HL7 segments, fields, components, or subcomponents, length information is declared. This indicates that the corresponding HL7 segment, etc., is stored in the *syngo.share* database, which limits the number of characters that can be used to define it. If the length of a given HL7 segment, etc., exceeds the defined limit, the provided information cannot be stored and hence the HL7 message cannot be processed successfully. If the length of an HL7 segment, etc., is not stated, the information is not stored by *syngo.share*, although it might be needed to process the HL7 message correctly.

Date and Time Information

As required by the HL7 Messaging Standard, all date and time information has to be formatted according to the following standardized format:

YYYY[MM[DD[HH[MM[SS[.S[S[S[S]]]]]]]]][+/-ZZZZ].

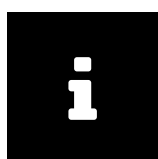
Timestamps which do not possess time zone information are assumed to be in local time. To avoid problems with timestamp conversions, all timestamps specified in HL7 messages sent by *syngo.share* are given in local time and hence do not specify any time zone offsets.

2.1 HL7 Message Syntax

To be able to parse and subsequently process HL7 messages, *syngo.share* requires them to have been generated according to the guidelines of the HL7 Messaging Standard. This entails special attention to the specification of the HL7 message delimiters (HL7 fields MSH-1 and MSH-2), the character sets (HL7 field MSH-18), and the alternate character set handling scheme (HL7 field MSH-20) as well as the use of the HL7 segment terminator.

2.1.1 HL7 Message Delimiters

syngo.share automatically detects the message delimiters of an HL7 message, which can be defined individually. To ensure that the detection succeeds, the HL7 field separator must be a US-ASCII character and the HL7 component separator, HL7 subcomponent separator, repetition separator, escape character, and truncation character must belong to the default character set of the HL7 message.



Note

The following US-ASCII characters may not be used as message delimiters because they fulfill other functions:

- Carriage return (hexadecimal 0d): HL7 segment terminator
- Escape (hexadecimal 1b): character set escape character (cf. alternate character set handling scheme ISO 2022-1994)
- " (hexadecimal 22): null character

Although the HL7 message delimiters can be defined individually, *syngo.share* recommends the use of the default HL7 message delimiters defined by the HL7 Messaging Standard. *syngo.share* requires each HL7 segment, even the last one, to be terminated by the HL7 segment terminator. This ensures that the end of an HL7 segment can be detected. As HL7 segment terminator, *syngo.share* expects a carriage return (hexadecimal 0d).

2.1.2 Character Sets

The *syngo.share* HL7 interface is fully internationalized. This means that the character sets used within an HL7 message are detected automatically by extracting the corresponding information from the HL7 field MSH-18. The first character set defines the default character set of an HL7 message. All other character sets define so-called alternate character sets, which can be used to specify characters that are not part of the default character set.

If no character set is defined, *syngo.share* assumes – in accordance with the HL7 Messaging Standard – that all characters used within a given HL7 message are part of US-ASCII. When alternate character sets are specified, the handling scheme of the alternate character sets (which determines how character set switches are indicated) has to be defined by the HL7 field MSH-20. If the character sets or the alternate character set handling scheme of an HL7 message are incomplete or incorrect, *syngo.share* is unable to parse the HL7 message.

Table 1 lists the supported character sets, their MIME names, the alternate character set handling schemes, and the escape sequences of the character sets with respect to the alternate character set handling schemes.

The character sets ISO IR87, ISO IR159, and KS X 1001 only can be used as alternate character sets because they are not based on US-ASCII. In contrast, the character sets 8859/15, CNS 11643-1992, GB 18030-2000, BIG-5, UNICODE UTF-8, UNICODE UTF-16, and UNICODE UTF-32 cannot be mixed with other character sets due to their lack of escape sequences.

In case of the character sets GB 18030-2000, UNICODE UTF-8, UNICODE UTF-16, and UNICODE UTF-32, mixing them with other character sets would also serve no purpose because they can encode all characters of the Unicode Standard.

syngo.share automatically detects the endianness of the character sets UNICODE UTF-16 and UNICODE UTF-32, meaning that both the little-endian and big-endian variants of these two character sets are supported. To allow switches between multiple character sets, *syngo.share* applies the rules defined by the HL7 Messaging Standard as well as ISO/IEC 2022 and ECMA-35. In accordance with these standards, character sets are divided into a GL level (lower bytes between 20 and 7f) and a GR level (higher bytes between a0 and ff). To ensure that the characters of the GL or GR level of a character set can be used, the desired character set switch has to be triggered by specifying the corresponding escape sequence.

Note that the escape sequences of the alternate character set handling scheme ISO 2022-1994, mentioned in [Table 1](#), are stated in hexadecimal. Since HL7 message delimiters have to be specified in the default character set, the scope of a character set switch is limited to the HL7 subcomponent in which it occurs. So at the end of each HL7 subcomponent, the character sets defined by the GL and GR level must be switched back to the default character set, if necessary.

2.2 HL7 Communication

syngo.share uses TCP/IP connections based on the Minimal Lower Layer Protocol specified by the HL7 Messaging Standard for communication with third-party systems. Within HL7 communications, *syngo.share* can act as either the receiver or sender of HL7 messages.

If *syngo.share* receives HL7 messages, it assumes that the connecting third-party system administrates the HL7 connection. This means that the HL7 connection is not closed by *syngo.share* as long as no irreparable error occurs.

If *syngo.share* sends HL7 messages to a third-party system, it assumes that it administrates the HL7 connection. *syngo.share* is robust against network problems because its HL7 outbound interface only opens an HL7 connection if HL7 messages have to be transmitted to a third-party system and closes an established HL7 connection as soon as all HL7 messages have been sent. To avoid the frequent establishment and termination of HL7 connections, *syngo.share* waits for a configured amount of time before reestablishing an HL7 connection to exchange further HL7 messages.

To receive and send HL7 messages, *syngo.share* follows either the original or the enhanced processing rules specified by the HL7 Messaging Standard. A received HL7 message is processed according to the original processing rules if the accept acknowledgment type (see HL7 field MSH-15) and application acknowledgment type (see HL7 field MSH-16) are null or not present. If the accept acknowledgment type or application acknowledgment type are specified, the enhanced processing rules are used to process the HL7 message.

In order to act as an HL7 message sender, *syngo.share* has to be configured to use either the original or the enhanced processing rules for the transmission of HL7 messages. In the latter case, *syngo.share* requires the transmission of HL7 accept acknowledgment messages but denies the exchange of HL7 application acknowledgment messages. To complement the two processing modes, *syngo.share* also supports the Sequence Number Protocol defined by the HL7 Messaging Standard.

syngo.share processes the received HL7 messages chronologically by their order of storage. To guarantee the correct processing of HL7 messages, they should always be sent in the correct chronological order. Likewise, when sending HL7 messages to third-party systems, *syngo.share* ensures that HL7 messages which depend on each other are transmitted in chronological order.

2.2.1 Reception of HL7 Messages

syngo.share checks each received HL7 message for syntactic and semantic correctness. Syntactically incorrect HL7 messages cannot be parsed and can thus neither be stored nor processed. Since the sending third-party system cannot be informed about syntactic errors even when the transmission of an HL7 accept acknowledgment message has been requested, *syngo.share* closes the HL7 connection.

To validate the HL7 message semantically, *syngo.share* checks whether the HL7 message type can be processed and whether the receiving facility specified by the HL7 field MSH-6 is related to one of the configured tenants. If the type of the received HL7 message is not supported by *syngo.share*, the message is rejected. If the reception of the HL7 message has to be acknowledged, *syngo.share* sends an HL7 accept acknowledgment message with the acknowledgment code AR or CR to the sending third-party system. AR is used if the original processing rules are applied; CR is used if the enhanced processing rules are used.

If *syngo.share* can process the received HL7 message type but the receiving facility does not address any of the configured tenants, the HL7 message is stored in a configured error directory in the file system. If the reception of the HL7 message has to be acknowledged, *syngo.share* sends an HL7 accept acknowledgment message with the acknowledgment code AE or CE to the sending third-party system. AE is used if the original processing rules are applied; CE is used if the enhanced processing rules are applied.

If the syntactic and semantic checks succeed, *syngo.share* stores the received HL7 message and schedules it for processing. If the reception of the HL7 message has to be acknowledged, *syngo.share* sends an HL7 accept acknowledgment message with the acknowledgment code AA or CA to the sending third-party system. AA is used if the original processing rules are applied; CA is used if the enhanced processing rules are applied.

If an HL7 message is transferred according to the enhanced processing rules, it might be necessary to exchange further information with the sending third-party system as soon as the HL7 message has been processed. To this end, *syngo.share* is able to send so-called HL7 application acknowledgment messages (see [Acknowledgment of Processed HL7 Messages](#) for further information).

2.2.2 Sending of HL7 Messages

When *syngo.share* sends an HL7 message to a third-party system, it always expects that system to acknowledge the reception. For positive acknowledgments, *syngo.share* requires the HL7 accept acknowledgment message to specify the acknowledgment code AA or CA. AA has to be specified if the original processing rules are used to transmit the HL7 message; CA has to be specified if the enhanced processing rules are used to transmit the HL7 message. The processing rules for the transfer of HL7 messages can be individually configured in *syngo.share*.

2.3 Country-Specific Requirements

syngo.share can meet the legal requirements of a given country and can do so in compliance with the IHE Technical Framework. *syngo.share* applies country-specific changes to HL7 communication at the tenant level, i.e. according to the country set in the tenant settings. This chapter describes how *syngo.share* handles specific countries.

2.3.1 France

French law mandates special requirements for HL7 communication (see the National Extensions chapter of the IHE Technical Framework for details). To fulfil these requirements, *syngo.share* core can automatically modify transmissions. Care has been taken to ensure that these implicit modifications are applied at the correct point in the chain of events to guarantee that forbidden data is never archived or transmitted.

2.3.1.1 Inbound Interface

When receiving transmissions, the following HL7 field values are emptied automatically:

- Patient Race PID-10, NK1-35
- Patient Religion PID-17, NK1-25
- Patient Ethnic Group PID-22, NK1-28

2.3.1.2 Outbound Interface

When sending transmissions, the following header information is added to indicate that they conform to French law:

The following fields are emptied automatically:

- Patient Race PID-10, NK1-35
- Patient Religion PID-17, NK1-25
- Patient Ethnic Group PID-22, NK1-28

3 HL7 Inbound Interface

3.1 Patient and Visit Administration

3.1.1 Operating Mode

The primary purpose of the HL7 interface is the synchronization of patient and visit information. For this purpose, *syngo.share* provides an interface that allows the third-party system managing the patient and visit base (e.g., HIS or RIS) to insert, update, delete, and merge patients as well as to insert, update, delete, move, and merge visits by sending HL7 ADT messages. Each HL7 ADT message has to be dedicated to exactly one patient and mostly one visit.

Since *syngo.share* does not support visits on the account level, it assumes that visit information always specifies a visit on the visit level (cf. HL7 Messaging Standard).

Within *syngo.share*, patients and visits are not just inserted via HL7 ADT messages. If a DICOM image or generic file is archived and the corresponding patient or visit does not exist, a new patient or visit is inserted. Similarly, if an order is inserted via HL7 OMI or HL7 ORM message but the specified patient or visit is unknown, it is inserted (see [Order Administration](#)).

3.1.1.1 Information Quality

The patient and visit information associated with DICOM images or generic files usually does not come directly from the third-party system which manages the patient and visit base. This means that such information is of lower quality than that provided by HL7 ADT or HL7 ORM messages. Patient and visit information is flagged as HL7-managed or non-HL7-managed information in order to preserve the origin of a patient and visit as well as to prevent HL7-managed information from being overwritten by non-HL7-managed information. Any patient or visit that is inserted during the processing of an HL7 ADT, HL7 OMI, or HL7 ORM message is marked as HL7-managed. Patients and visits which are inserted during import processes are flagged as non-HL7-managed.

HL7-managed patients are identified by a patient ID, whereas non-HL7-managed patients are identified by so-called identification tuples consisting of a patient ID as well as the last name, first name, birth timestamp, and sex of the patient. The reason for the quite complex identification of non-HL7-managed patients is related to the fact that patient IDs of non-HL7-managed patients may not be correct. So to avoid scenarios wherein non-HL7-managed patients accidentally overwrite each other, the identification tuple is used to uniquely identify non-HL7-managed patients. In the case of visits, the situation is much simpler. Since visits can be identified by just a visit ID, the identification method for HL7-managed visits and non-HL7-managed visits is the same.

3.1.1.2 Patients

syngo.share upholds the rules proposed by the HL7 Messaging Standard to insert, update, delete, and merge patients. This means that if a patient is to be inserted or updated, *syngo.share* first checks if an HL7-managed patient with the specified patient ID or a non-HL7-managed patient with the specified identification tuple exists.

- If no patient is found, an HL7-managed patient with the information specified in the HL7 ADT message is inserted.
- If an HL7-managed patient is found, *syngo.share* first checks whether the last name, first name, birth timestamp, or sex of the patient will be changed. If this is the case, the found patient is invalidated by a newly inserted patient. This newly inserted patient represents an updated version of the found patient.

- If a non-HL7-managed patient is found, it is updated and transformed into an HL7-managed patient. An invalidation tree is not constructed. See [Invalidation Trees](#).
- If a patient has to be deleted, *syngo.share* first checks whether the patient exists. If so, this patient is deleted; if not, the HL7 ADT message is ignored.
- Finally, if two patients have to be merged, *syngo.share* first checks whether the new patient exists. If so, the found patient is updated and transformed into an HL7-managed patient if needed. If not, an appropriate HL7-managed patient is inserted. Afterwards, *syngo.share* checks whether the old patient exists. If so, the old patient is invalidated by the new patient in order to maintain a possibly existing invalidation tree (see [Invalidation Trees](#)).

3.1.1.3 Visits

When inserting, updating, deleting, moving, or merging visits, *syngo.share* proceeds as follows:

- If a visit is to be inserted or updated, *syngo.share* first checks whether an HL7-managed or non-HL7-managed visit with the specified visit ID exists. If no visit is found, an HL7-managed visit with the information specified in the HL7 ADT message is inserted. Otherwise, the found visit is updated and transformed into an HL7-managed visit.
- If a visit has to be deleted, *syngo.share* first checks if it exists. If so, it is deleted; if not, the HL7 ADT message is ignored.
- If a visit has to be moved from one patient to another, *syngo.share* checks whether the visit exists. If this is not the case, an HL7-managed visit belonging to the requested patient is inserted. Otherwise, the found visit is updated, transformed into an HL7-managed visit if necessary, and moved to the requested patient.
- Finally, if two visits have to be merged, *syngo.share* first checks if the new visit exists. If so, the found visit is updated and transformed into an HL7-managed visit if necessary. If not, an appropriate HL7-managed visit is inserted. Afterwards, *syngo.share* checks if the old visit exists. If so, the old visit is invalidated by the new visit in order to maintain a possibly existing invalidation tree (see [Invalidation Trees](#)).

3.1.1.4 Invalidation Trees

Invalidation trees are used to save the history of critical changes. The reason for the construction of invalidation trees is rooted in the fact that patient and visit information of DICOM images and generic files may have become obsolete after they have been archived by *syngo.share*. So if a DICOM image or generic file consists of old patient/visit information, *syngo.share* tries to find a patient/visit by searching for an invalidated patient/visit with the given identification tuple (visit ID). If the search is successful, the DICOM image or generic file is assigned to the correct patient/visit without further ado.

3.1.2 HL7 ADT Message Structure

3.1.2.1 HL7 Trigger Events

To administrate patients and visits via HL7 ADT messages, *syngo.share* supports the following trigger events:

A01 to A04	A28	A42
A06 to A08	A29	A45
A11 to A13	A31	A47
A18	A34	A50
A23	A40	

Other trigger events associated with HL7 ADT messages are currently not supported by *syngo.share*. The listed trigger events are used for the following purposes:

■ A01, A02, A03, A04, A12, and A13

These trigger events are used to insert or update a patient and visit. An HL7 ADT message associated with one of these trigger events has to conform to the following structure:

MSH PID [NK1] PV1 [ROL] [GT1] [ACC]

■ A06 and A07

These trigger events are used to insert or update a patient and visit. If an HL7 MRG segment is defined, the specified visit is merged with the visit specified by the HL7 PV1 segment. The structure of such an HL7 ADT message looks as follows:

MSH PID [MRG] [NK1] PV1 [ROL] [GT1] [ACC]

■ A08, A28, and A31

These trigger events are used to insert or update a patient without specifying a visit. If a visit is present, however, it is inserted or updated. Trigger event A31 allows the XAD-PID of referenced patients to be set if the message contains one patient ID marked with type GPI as XAD-PID. An HL7 ADT message associated with one of these trigger events has to conform to the following structure:

MSH PID [NK1] [PV1] [ROL] [GT1] [ACC]

■ A11 and A23

These trigger events are used to delete a visit. An HL7 ADT message associated with one of these trigger events has to provide the following information:

MSH PID PV1

■ A18, A34, and A40

These trigger events are used to merge two patients. To this end, an associated HL7 ADT message has to specify the following HL7 segments:

MSH PID MRG [NK1] [GT1]

■ A29

This trigger event is used to delete a patient. The structure of such an HL7 ADT message looks as follows:

MSH PID

■ A42

This trigger event is used to merge a visit. If the patient associated with the new visit does not exist, it is created. Otherwise, it is updated. An HL7 ADT message associated with this trigger event has to conform to the following structure:

MSH PID MRG [NK1] PV1 [ROL] [GT1] [ACC]

■ A45

This trigger event is used to move a visit specified in the HL7 MRG segment. If the patient specified in the HL7 ADT message does not exist, it is created. Otherwise, it is updated. When an HL7 ADT message specifies a visit with a HL7 PV1 segment, the moved visit is updated if the two visit IDs are identical. Otherwise, the moved visit is merged with the new visit specified by the HL7 PV1 segment. If no visit exists, a new one is created. The structure of such an HL7 ADT message looks as follows:

MSH PID MRG [NK1] [PV1] [ROL] [GT1] [ACC]

■ A47

This trigger event is used to update the patient ID of a patient. To perform this operation, *syngo.share* invalidates the old patient by creating a new patient that represents an updated version of the old patient. HL7 ADT messages of this type have to provide the following information:
MSH PID MRG [NK1] [GT1]

■ A50

This trigger event is used to replace the visit ID of a visit. To guarantee a consistent construction of invalidation trees (see [Invalidation Trees](#)), *syngo.share* invalidates the old visit by creating a new visit that represents an updated version of the old visit. An HL7 ADT message associated with this trigger event has to conform to the following structure:
MSH PID MRG [NK1] PV1 [ROL] [GT1] [ACC]

3.1.2.2 HL7 Elements

The following HL7 fields, components and segments have to be specified regardless of the trigger event:

■ PID-3.1

This HL7 component has to specify the patient ID of the given patient.

■ PV1-19.1

This HL7 component has to specify the visit ID.

■ ROL, NK1 and GT1

These HL7 segments can be specified whenever the used trigger event might cause the insertion or update of the stated patient or visit. The specification of these segments is not part of the official structure defined by the HL7 Messaging Standard.

3.2 Order Administration

3.2.1 Operating Mode

The HL7 inbound interface of *syngo.share* allows third-party systems (e.g., HIS or RIS) to insert, update, and delete orders, Requested Procedures, and Scheduled Procedure Steps by sending HL7 OMI and HL7 ORM messages. Each HL7 OMI message must be dedicated to exactly one order, whereas an HL7 ORM message has to focus on a particular Requested Procedure of an order. HL7 OMI messages should be preferred over HL7 ORM messages since they represent the state of the art and facilitate a more compact and simpler specification of orders, Requested Procedures, and Scheduled Procedure Steps. The processing of multiple orders within an HL7 OMI or HL7 ORM message is not supported.

To uniquely identify an order, *syngo.share* uses either the Placer Order Number or Filler Order Number. Since the Filler Order Number is usually more specific than the Placer Order Number, the Filler Order Number is given preference whenever it is specified. If the Filler Order Number is not given, the Placer Order Number is used. The ID used to identify an order is henceforth simply called order ID.

Each order consists of one or more Requested Procedures. To associate Requested Procedures with DICOM studies, *syngo.share* follows the guidelines proposed by the IHE Radiology Technical Framework. This means that in order to uniquely identify a Requested Procedure, *syngo.share* uses the Study Instance UID of the resulting DICOM study specified by the received HL7 OMI (see HL7 IPC segment) or HL7 ORM message (see HL7 ZDS segment).

Each Requested Procedure is subdivided into one or more Scheduled Procedure Steps. To uniquely identify a Scheduled Procedure Step, *syngo.share* uses the Scheduled Procedure Step ID.

3.2.1.1 Insertions and Updates

When *syngo.share* receives an HL7 OMI or HL7 ORM message to insert or update an order, Requested Procedure, or Scheduled Procedure Step, *syngo.share* proceeds as follows:

- First, it checks whether an order with the given order ID exists. If so, the order information is updated. If not, the order is created using the information provided by the HL7 OMI or ORM message.
- If the patient or visit associated with the order does not exist, an HL7-managed patient or visit is inserted. If the patient or visit exists but is non-HL7-managed, it is updated and transformed into an HL7-managed patient or visit (see [Patient and Visit Administration](#) for detailed information).
- Afterwards, *syngo.share* checks for each specified Requested Procedure whether the created or found order possesses a Requested Procedure with the specified Study Instance UID. If so, the corresponding Requested Procedure is updated. If not, the Requested Procedure is created.
- Likewise, for each Scheduled Procedure Step, *syngo.share* checks whether the dedicated Requested Procedure consists of a Scheduled Procedure Step with the stated Scheduled Procedure Step ID. If so, the corresponding Scheduled Procedure Step is updated. If not, the Scheduled Procedure Step is created.

3.2.1.2 Deletions

When *syngo.share* receives an HL7 OMI or HL7 ORM message to delete an order, it proceeds as follows:

- It checks whether the order exists by using the specified order ID. If the order exists, it is deleted, including all associated Requested Procedures and Scheduled Procedure Steps. If not, the HL7 OMI or HL7 ORM message is ignored.

Note that it is not possible to delete individual Requested Procedures or Scheduled Procedure Steps with HL7 OMI or HL7 ORM messages.

3.2.1.3 Metadata Updates

syngo.share provides the means to synchronize Requested Procedures and DICOM studies by setting up a so-called metadata update. In this particular case, whenever a Requested Procedure is inserted or updated by an HL7 OMI or HL7 ORM message, *syngo.share* checks if the specified DICOM study already exists. If so, *syngo.share* first synchronizes the metadata of the existing DICOM study by modifying the values of the following DICOM tags:

Afterwards, the existing DICOM study is reallocated to the patient and visit associated with the order, if necessary.

This ensures that corrective workflows based on orders, as defined by the IHE Radiology Technical Framework, succeed independent of the quality of the patient and visit data of the DICOM study.

3.2.1.4 DICOM Worklists

syngo.share also provides DICOM worklists for the administration of orders. It stores a DICOM worklist for each Scheduled Station AET that has been addressed by at least one HL7 OMI or HL7 ORM message. When an HL7 OMI or HL7 ORM message specifies an order that is scheduled for processing, its Scheduled Procedure Steps are placed on the worklists of the assigned Scheduled Station AETs. A Scheduled Procedure Step is removed from a DICOM worklist when one of the following occurs:

- The corresponding DICOM study is archived. In this case, the Study Instance UID and Scheduled Procedure Step IDs of the DICOM study are used to identify affected Scheduled Procedure Steps.
- The associated order is marked as completed by an order status update via HL7 OMI or HL7 ORM message. In this case, all Scheduled Procedure Steps of the order are removed from the worklist.

Further information about worklists can be found in the *syngo.share* DICOM Conformance Statement.

3.2.2 HL7 OMI Message Structure

3.2.2.1 HL7 Trigger Events

To insert, update, and delete orders, Requested Procedures, and Scheduled Procedure Steps via HL7 OMI messages, *syngo.share* supports the trigger event 023 as prescribed by the HL7 Messaging Standard.

Other trigger events associated with HL7 OMI messages are neither supported by the HL7 Messaging Standard nor by *syngo.share*. To ensure that *syngo.share* can process HL7 OMI messages, they must adhere to the following structure:

MSH PID [NK1] [PV1] [ROL] [GT1] [ACC] {ORC TQ1 OBR [{PRT}] {IPC}}

3.2.2.2 HL7 Elements

■ ORC-1

To distinguish between HL7 OMI messages which insert, update, and delete orders, Requested Procedures, and Scheduled Procedure Steps, *syngo.share* relies on the valid specification of the HL7 field ORC-1:

- **NW:** This value is used to insert an order, Requested Procedure, or Scheduled Procedure Step.
- **XO or DC:** These values are used to update an order, Requested Procedure, or Scheduled Procedure Step. XO indicates an ordinary modification of an order, etc., whereas DC announces the discontinuation of an order, etc.
- **SC:** This value is used to modify the document workflow state via **OBR-25.1**. The order is left untouched.
- **CA:** This value is used to delete an order.

■ ORC-5

When *syngo.share* is used to provide DICOM worklists, the HL7 field ORC-5 has to be specified:

- **SC:** This value is used to ensure that the listed Scheduled Procedure Steps are scheduled for processing.
- **CM:** This value is used to mark an order as completed, thus removing all Scheduled Procedure Steps from worklists.

■ OBR-2.1 and OBR-3.1; ORC-2.1 and ORC-3.1

These HL7 components have to specify the Placer Order Number (OBR-2.1 and ORC-2.1) and the Filler Order Number (OBR-3.1 and ORC-3.1).

■ PRT

This HL7 segment can be used to transmit participation information.

■ IPC-3.1

This HL7 component has to specify the Study Instance UID.

■ IPC-4.1

This HL7 component has to define a unique Scheduled Procedure Step ID for each Scheduled Procedure Step.

■ IPC-9

This HL7 field has to define the Scheduled Station AET associated with each Scheduled Procedure Step.

■ PV1

This HL7 segment should be present if and only if the underlying order belongs to a visit.

■ ROL and NK1

The specification of these segments is possible, although it is not part of the official structure defined by the HL7 Messaging Standard.

Note that each HL7 OMI message is dedicated to exactly one order. To define more than one Requested Procedure, the HL7 ORC/TQ1/OBR/IPC segment group has to be repeated appropriately often. To divide a Requested Procedure into multiple Scheduled Procedure Steps, the HL7 IPC segment has to be repeated the correct number of times within the corresponding HL7 ORC/TQ1/OBR/IPC segment group.

If more than one Requested Procedure (Scheduled Procedure Step) is defined, information related to the order (i.e. order and Requested Procedure) must not vary.

3.2.3 HL7 ORM Message Structure

3.2.3.1 HL7 Trigger Events

To insert, update, and delete orders, Requested Procedures, and Scheduled Procedure Steps via HL7 ORM messages, *syngo.share* supports the trigger event 001 as proposed by the HL7 Messaging Standard.

Other trigger events associated with HL7 ORM messages are neither supported by the HL7 Messaging Standard nor by *syngo.share*. To ensure that *syngo.share* can process HL7 ORM messages they have to adhere to the following structure:

MSH PID [NK1] [PV1] [ROL] [GT1] [ACC] {ORC OBR} [ZDS]

3.2.3.2 HL7 Elements

¶ ORC-1

To distinguish between HL7 ORM messages which insert, update, and delete orders, Requested Procedures, and Scheduled Procedure Steps, *syngo.share* relies on the valid specification of the HL7 field ORC-1.

- NW: This value is used to insert an order, Requested Procedure, or Scheduled Procedure Step.
- XO or DC: These values are used to update an order, Requested Procedure, or Scheduled Procedure Step. XO indicates an ordinary modification of an order, etc., whereas DC announces the discontinuation of an order, etc.
- SC: This value is used to modify the document workflow state via OBR-25.1. The order is left untouched.
- CA: This value is used to delete an order.

¶ ORC-5

When *syngo.share* is used to provide DICOM worklists, the HL7 field ORC-5 has to be specified:

- SC: This value is used to ensure that the listed Scheduled Procedure Steps are scheduled for processing.
- CM: This value is used to mark an order as completed, thus removing all Scheduled Procedure Steps from worklists.

¶ OBR-2.1 and OBR-3.1; ORC-2.1 and ORC-3.1

These HL7 components have to specify the Placer Order Number and Filler Order Number.

¶ ZDS-1.1

This HL7 component should specify the Study Instance UID. If the ZDS segment is not given, the Study Instance UID of the Requested Procedure corresponding to OBR-19 is used if possible; otherwise, a new Study Instance UID is created.

¶ OBR-20

This HL7 field has to define a unique Scheduled Procedure Step ID for each Scheduled Procedure Step.

¶ PV1

This HL7 segment should be used if and only if the underlying order belongs to a visit.

¶ ROL and HL7 NK1

The specification of these HL7 segments is possible, although it is not part of the official structure defined by the HL7 Messaging Standard.

Note that each HL7 ORM message is dedicated to exactly one Requested Procedure. To define more than one Scheduled Procedure Step, the HL7 ORC/OBR segment group has to be repeated appropriately often.

If more than one Requested Procedure (Scheduled Procedure Step) is defined, information related to the order (i.e. order and Requested Procedure) must not vary.

3.3 Archiving of Generic Files

3.3.1 Operating Mode

syngo.share provides various interfaces for archiving generic files. The most frequently used interface is based on the HL7 Messaging Standard.

In general, any type of generic file can be archived. To allow third-party systems to synchronize their data with *syngo.share*, it is possible to insert, update, and delete generic files.

Both HL7 MDM and HL7 ORU messages can be used to archive generic files via the HL7 interface. However, it is strictly recommended to use HL7 MDM messages instead of HL7 ORU messages. The use of HL7 MDM messages is favored by the HL7 Messaging Standard since they allow for a more fine-grained specification of generic files. In addition, some functionalities like the XDS registration of a generic file in an Affinity Domain rely on metadata, which can only be specified by an HL7 MDM message.

3.3.1.1 Transmission of the Binary Data

Each HL7 MDM and HL7 ORU message must be dedicated to exactly one generic file. The binary data of a generic file can be transmitted by either reference or value:

- Transmission by reference requires the generic file to be written to a share and to be referenced by a UNC path that adheres to the following format:
 - Windows: \\<host>\<share>\<path>
 - Linux: //<host>/<share>/<path>
- Transmission by value requires the binary data to be encapsulated in the HL7 MDM or HL7 ORU message. Since transmitting non-printable characters within an HL7 message is not allowed, the binary data must be encoded so that the sent HL7 MDM or HL7 ORU message is syntactically correct and can hence be parsed by *syngo.share*. *syngo.share* supports the following encodings:

- A: The binary data is encoded as an HL7-escaped string.
- Base64: The binary data is Base64-encoded. It is recommended to ignore the maximum line length of 76 characters required by RFC 2045. If not, line breaks have to be HL7-escaped.
- Hex: The binary data has to be encoded as a hexadecimal string.
- UU: The binary data has to be UU-encoded. Note that non-printable characters have to be HL7-escaped.

3.3.1.2 Identification

syngo.share uses two IDs to uniquely identify generic files: a generic file ID and an application ID. The application ID is needed to identify the third-party system that archives the generic file, whereas the generic file ID is used to identify the generic file among the generic files inserted by the sending third-party system.

Each generic file is archived in *syngo.share* within a so-called generic container. Generic containers are used to group generic files. They are identified by a generic container ID and a coding system ID. Since a generic container might be reused for patients and shared between third-party systems, the combination of generic container ID and coding system ID needs to be unique.

However, to ensure that generic containers can be used in a meaningful way, *syngo.share* ensures that a patient does not possess two generic containers with identical generic container ID and coding system ID related to a particular visit and Organizational Unit. In other words, the integration of a generic file into a generic container takes place with respect to the associated patient, visit, and Organizational Unit.

3.3.1.3 Insertion and Update

The approach used by *syngo.share* to insert or update a generic file depends on the type of the HL7 message.

HL7 MDM Messages

If an HL7 MDM message is used to update a generic file, the HL7 Messaging Standard states that a new generic file ID should be generated which is linked to the original generic file by specifying the old generic file ID.

Since the generation of a new generic file ID might be impossible or inconvenient, *syngo.share* supports the update of generic files without changing the generic file ID. When inserting or updating a file via HL7 MDM message, *syngo.share* primarily checks if a generic file with the specified new generic file ID and application ID or an old generic file ID and application ID already exist.

- If neither the new generic file ID nor the old generic file ID yields a generic file archived by *syngo.share* (the IDs may be undefined), the generic file is stored based on the patient, visit, and Organizational Unit information specified by the HL7 MDM message.
- If the specified patient or visit does not exist, a non-HL7-managed patient or visit is inserted. An update of an existing patient or visit is not performed (see [Patient and Visit Administration](#) for detailed information).
- If the old generic file ID and application ID reference a generic file stored by *syngo.share* but the new generic file ID and application ID do not, the metadata of the generic file identified by the old generic file ID and application ID are updated and the old generic file ID is replaced by the new generic file ID. If the binary data of the generic file has changed too, a new version of the generic file is stored.

- If the new generic file ID and application ID address a generic file archived by *syngo.share* but the old generic file (which may be undefined) and application ID do not, the generic file identified by the new generic file ID and application ID is updated (metadata and binary data if present).
- If both the new generic file ID and application ID as well as the old generic file ID and application ID refer to a generic file archived by *syngo.share*, an error is reported if the new generic file ID and the old generic file ID are different. If the generic file IDs are identical, the metadata of the found generic file is updated without changing the generic file ID. Furthermore, if the binary data of the generic file has changed too, a new version of the generic file is archived.

HL7 ORU Messages

The processing of HL7 ORU messages which insert or update generic files is much easier because generic file IDs cannot be changed via HL7 ORU messages. So to insert or update a generic file via HL7 ORU message, *syngo.share* primarily checks if a generic file with the specified generic file ID and application ID already exists.

- If this is not the case, the generic file is archived based on the patient, visit, and Organizational Unit information specified by the HL7 ORU message.
- If the specified patient or visit does not exist, a non-HL7-managed patient or visit is inserted. An update of an existing patient or visit is not performed (see [Patient and Visit Administration](#) for detailed information).
- If the generic file exists, the metadata of the generic file are updated. If the binary data of the generic file changed too, a new version of the generic file is stored. Note that if a generic file is updated via HL7 MDM or HL7 ORU message, any specified patient, visit, and Organizational Unit information are ignored.

3.3.1.4 Deletion

syngo.share uses the same approach to delete generic files, regardless of the type of HL7 message. To delete a generic file, *syngo.share* simply checks whether a generic file with the specified generic file ID and application ID exists.

- If this is the case, the corresponding generic file is deleted. Afterwards, *syngo.share* checks if its corresponding generic container now only consists of deleted generic files. If so, the generic container is deleted too.
- If the generic file to be deleted does not exist, *syngo.share* ignores the sent HL7 MDM or HL7 ORU message.

3.3.2 HL7 MDM Message Structure

3.3.2.1 HL7 Trigger Events

To insert, update, and delete generic files via HL7 MDM messages, *syngo.share* supports the following trigger events:

!T02

This trigger event is used to insert a generic file.

!T09

This trigger event is used to update the metadata of a generic file.

■ T10

This trigger event is used to update the metadata and binary data of a generic file.

■ T11

This trigger event is used to delete a generic file.

Other trigger events associated with HL7 MDM messages are currently not supported by *syngo.share*.

For trigger events T02 and T10, HL7 MDM messages have to comply with the following structure:
MSH PID [NK1] [PV1] [ROL] [GT1] [ACC] [{ORC OBR}] TXA {OBX} [{ZRI}]

For trigger events T09 and T11, HL7 MDM messages have to comply with the following structure:
MSH PID [NK1] [PV1] [ROL] [GT1] [ACC] [{ORC OBR}] TXA [{OBX}] [{ZRI}]

3.3.2.2 HL7 Elements

The following HL7 elements have to be present for specific trigger events:

■ OBX

This HL7 segment has to be present in order to ensure that *syngo.share* can process HL7 MDM messages associated with trigger events T02 and T10. The OBX segment contains the binary data.

Note that the use of more than one HL7 OBX segment for the transmission of the binary data of a generic file is not permitted. This is in accordance with the HL7 Messaging Standard. However, repetitions of the HL7 OBX segment can be used to submit referenced Study Instance UIDs.

HL7 MDM messages associated with trigger events T09 and T11 do not need to specify the OBX segment since they do not provide any binary data.

Regardless of the trigger event, the following HL7 elements have to be present:

■ TXA-12.1

This HL7 component has to specify the generic file ID.

■ MSH-3

This HL7 field has to specify the application ID. If the HL7 component MSH-3.1 is specified, it is evaluated. If it has been left blank, MSH-3.2 is used instead.

■ TXA-24.1 and TXA-24.3

These components have to define the generic container ID and the coding system ID.

■ PV1

This segment should be present if and only if the underlying generic file belongs to a visit.

The following HL7 elements are optional:

■ ROL, NK1, and GT1

The specification of these HL7 segments is possible, although it is not part of the official structure defined by the HL7 Messaging Standard.

■ OBX

This segment can be specified for HL7 MDM messages associated with the trigger event T09 in order to update metadata. Its specification is not part of the official structure defined by the HL7 Messaging Standard.

■ ZRI

Repetitions of the proprietary ZRI segment can be specified; these are transmitted as Reference IDs during an XDS registration of the corresponding generic file.

Furthermore, *syngo.share* supports the specification of multiple HL7 ORC/OBR segment pairs for submitting information about linked procedures. If there is only one HL7 OBR segment present, the specification of an HL7 ORC segment (as requested by the HL7 Messaging Standard) is not necessary.

3.3.3 HL7 ORU Message Structure

3.3.3.1 HL7 Trigger Events

To insert, update, and delete generic files via HL7 ORU messages, *syngo.share* supports the trigger event R01 as proposed by the HL7 Messaging Standard. Other trigger events associated with HL7 ORU messages are not supported by *syngo.share*.

To ensure that *syngo.share* can process HL7 ORU messages within this context they have to meet the following structure:

MSH PID [NK1] [PV1] [ROL] [GT1] [ACC] [{ORC OBR}] {OBX}

3.3.3.2 HL7 Elements

Unlike HL7 MDM messages, HL7 ORU messages do not possess HL7 TXA segments. Hence, the IDs used to identify generic files and generic containers are defined by other HL7 components.

Note that the transmission of the binary data of a generic file by using more than one HL7 OBX segment is not permitted. This is in accordance with the HL7 Messaging Standard. However, repetitions of the HL7 OBX segment can be used to submit referenced Study Instance UIDs.

■ OBR-25 and OBX-11

The valid specification of these HL7 fields is necessary to distinguish between HL7 ORU messages which insert or update generic files and HL7 ORU messages which delete generic files:

- F: This value has to be specified in both fields in order to insert or update a generic file.
- D: This value has to be specified in order to delete a generic file.

■ OBX-3.1

The generic file ID has to be defined in this HL7 component.

■ OBX-3.4 and OBX-3.6

These components have to define the generic container ID and the coding system ID.

■ MSH-3

The application ID has to be defined by this HL7 field.

■ PV1

This segment should be present if and only if the underlying generic file belongs to a visit.

■ ROL and GT1

The specification of these segments is possible, although it is not part of the official structure defined by the HL7 Messaging Standard.

Furthermore, *syngo.share* supports the specification of multiple HL7 ORC/OBR segment pairs for submitting information about linked procedures. If there is only one HL7 OBR segment present, the specification of an HL7 ORC segment (as requested by the HL7 Messaging Standard) is not necessary.

3.4 Changing the Organizational Unit of DICOM Studies and Generic Containers

3.4.1 Operating Mode

The Organizational Unit of DICOM studies and generic containers can be changed via the HL7 inbound interface.

HL7 ORU messages can be used to move DICOM studies and generic containers to another Organizational Unit. Each HL7 ORU message must be dedicated to exactly one DICOM study or generic container.

To ensure that *syngo.share* can uniquely identify the DICOM study or generic container, the reference pointer of the DICOM study or generic container has to be specified. Reference pointers can be automatically obtained from *syngo.share* via HL7 ORU messages (see [Referencing of DICOM Studies and Generic Containers](#) for further information).

3.4.2 HL7 ORU Message Structure

3.4.2.1 HL7 Trigger Events

To change the Organizational Unit of DICOM studies and generic containers via HL7 ORU messages, *syngo.share* supports the trigger event R01. The transmitted HL7 ORU messages have to meet the following structure:

MSH OBX ZOU

3.4.2.2 HL7 Elements

OBX-5.1

This HL7 component has to specify the reference pointer which identifies the DICOM study or generic container whose Organizational Unit should be changed.

ZOU

This segment should be present to specify the target Organizational Unit.

3.5 Sharing of DICOM Studies and Generic Containers

3.5.1 Operating Mode

DICOM studies and generic containers can be shared via the HL7 inbound interface. This means that they can be accessed by designated users via the **Inbox** in *syngo.share* webview.

HL7 ORU messages have to be used to share DICOM studies and generic containers. To allow third-party systems to administrate shares of DICOM studies and generic containers, it is possible to create and delete shares. Each HL7 ORU message has to be dedicated to exactly one DICOM study or generic container. There are no restrictions on the number of users for which a share is to be created or deleted.

Since each share allows exactly one user to access a specific DICOM study or generic container, each HL7 ORM message has to specify for all listed users whether a share for the referenced DICOM study/ generic container is to be created or whether an existing share is to be deleted. In other words, it is possible to create or delete shares with one HL7 ORU message.

The reference pointer of the DICOM study or generic container has to be specified in order to ensure that *syngo.share* can uniquely identify the DICOM study or generic container which is to be shared or whose share is to be deleted. Reference pointers can be automatically obtained from *syngo.share* via HL7 ORU messages (see [Referencing of DICOM Studies and Generic Containers](#) for further information).

To identify a user, *syngo.share* expects the login name of the user to be stated.

3.5.2 HL7 ORU Message Structure

3.5.2.1 HL7 Trigger Events

To administrate DICOM study and generic container shares via HL7 ORU messages, *syngo.share* supports the trigger event R01. The transmitted HL7 ORU messages have to meet the following structure: MSH OBX {PRT}

3.5.2.2 HL7 Elements

⌚ PRT-2

The specification of this HL7 field must be valid in order to allow *syngo.share* to distinguish between shares that have to be created and shares which are to be deleted.

- LI: This value has to be specified when a share is to be created.
- UN: This value has to be specified when a share is to be deleted.

⌚ OBX-5.1

This HL7 component has to specify the reference pointer which identifies the DICOM study or generic container that is to be shared.

⌚ PRT-1.1 and PRT-8.1

These HL7 components have to define the login name of the user (PRT-1.1) and the domain (PRT-8.1). To specify more than one user, the HL7 PRT segment has to be repeated appropriately often.

3.6 Deletion of DICOM Studies and Generic Containers

3.6.1 Operating Mode

DICOM studies and generic containers can be deleted via the HL7 inbound interface. Since this way of deletion is not standardized, it is recommended to use KOS Rejection Notes to delete DICOM images (see the *syngo.share* DICOM Conformance Statement) and HL7 MDM or HL7 ORU messages to delete generic files (as described in [Archiving of Generic Files](#)).

If the standardized deletion is out of the question, HL7 ORU messages can be used to delete DICOM studies and generic containers. Each HL7 ORU message must be dedicated to exactly one DICOM study or generic container.

To ensure that *syngo.share* can uniquely identify the DICOM study or generic container which is to be deleted, the reference pointer of the DICOM study or generic container has to be specified. Reference pointers can be automatically obtained from *syngo.share* via HL7 ORU messages (see [Referencing of DICOM Studies and Generic Containers](#) for further information).

3.6.2 HL7 ORU Message Structure

3.6.2.1 HL7 Trigger Events

To delete DICOM studies and generic containers via HL7 ORU messages, *syngo.share* supports the trigger event R01. The transmitted HL7 ORU messages have to meet the following structure:

MSH OBX

3.6.2.2 HL7 Elements

OBX-5.1

This HL7 component has to specify the reference pointer which identifies the DICOM study or generic container that is to be deleted.

3.7 Administration of HL7 ZPA Messages

3.7.1 Operating Mode

The HL7 inbound interface in *syngo.share* allows third-party systems to change the Accession Number and Study Instance UID of DICOM studies and to move DICOM studies from one patient to another via ZPA messages. If two DICOM studies are merged, the resulting DICOM study is assigned to the target patient. The corresponding order is deleted.

This interface should only be used in *syngo.plaza* installations where this kind of messages is important for synchronization. Otherwise, HL7 order messages and DICOM KOS objects should be used to realize this type of workflow.

3.7.2 Limitations

This proprietary interface has the following limitations:

- Changes made via HL7 ZPA messages are not persistent. If the HL7 message is received before the DICOM images, the patient context and the Accession Number of the DICOM images will not be corrected. If a DICOM image is stored for an already corrected DICOM study, the Accession Number is changed back to the original value.
- When a DICOM study is moved to another patient, the visit context is lost in *syngo.share*.
- In case of an error, the messages are skipped and are not added to the error list. Therefore, the intactness of the history of incoming HL7 ZPA messages cannot be guaranteed.
- If the Study Instance UID is changed, the reimport of the DICOM study will cause a UID conflict.

3.7.3 HL7 ZPA Message Structure

3.7.3.1 HL7 Trigger Events

syngo.share supports HL7 ZPA messages with the trigger events I05 and S05. I05 messages use the Accession Number and S05 the Study Instance UID to identify the DICOM studies.

The transmitted HL7 ZPA messages have to meet the following structure:

MSH PID [MRG] ZPA

3.7.3.2 HL7 Elements

MRG

This HL7 segment should be specified if the patient context of the referenced DICOM studies is to be checked.

By default, the processor has a modification which allows the processing of ZPA messages intended for *syngo.plaza*. For this purpose, MRG-4 is mapped to MRG-1 and, if no MRG segment is present, the segment ZSP is mapped to the MRG segment.

3.8 HL7 Segments

3.8.1 HL7 MSH Segment

The MSH segment of an incoming HL7 message has to provide the following information:

MSH-3.1 and MSH-3.2

These HL7 components have to define the sending application of the HL7 message uniquely. *syngo.share* requires at least one of the two HL7 components to be specified. If MSH-3.1 is left empty, the value of MSH-3.2 is used to identify the sending application. In all other cases, MSH-3.1 is evaluated.

Note that to insert, update, or delete a generic file, the specified sending application is used as application ID to uniquely identify the third-party system responsible for the generic file (cf. [Archiving](#)

of Generic Files).

■ MSH-4.1 and MSH-4.2

These HL7 components are used to identify the sending facility of the HL7 message. At least one of the two HL7 components has to be specified because *syngo.share* uses this information to identify the Organizational Unit affected by the HL7 message. If MSH-4.1 is left empty, the value of MSH-4.2 is used to retrieve the Organizational Unit. In all other cases, MSH-4.1 is evaluated.

■ MSH-5.1 and MSH-5.2

These HL7 components specify the receiving application. The evaluation of the receiving application is similar to that of the sending application. Since the processing of an HL7 message does not rely on this information, it does not have to be specified.

■ MSH-6.1 and MSH-6.2

These HL7 components are used to obtain the receiving facility of the HL7 message. *syngo.share* uses this to identify the tenant affected by the HL7 message. The evaluation of the HL7 components MSH-6.1 and MSH-6.2 is similar to that of the sending facility. This means that if MSH-6.1 is not specified, MSH-6.2 has to define the receiving facility.

■ MSH-15 and MSH-16

These HL7 fields define the following:

- The processing rules that have to be applied to exchange the HL7 message
- The conditions under which an HL7 accept acknowledgment message or an HL7 application acknowledgment message has to be sent when the enhanced processing rules are in effect.

To ensure that the original processing rules are used, both HL7 fields have to be left empty. If the enhanced processing rules are to be applied, at least one of the two HL7 fields has to be defined.

■ MSH-18 and MSH-20

The HL7 field MSH-18 has to specify the character sets used to generate the HL7 message. If more than one character set is in use, the handling scheme of the alternate character sets has to be defined by the HL7 field MSH-20. For the possible values of MSH-18 and MSH-20, refer to [HL7 Message Syntax](#).

3.8.2 HL7 PID Segment

The HL7 PID segment of an incoming HL7 message has to provide the following information:

PID-1

This HL7 field should specify the value 1. Note that *syngo.share* cannot process more than one HL7 PID segment.

PID-3.1 and PID-3.5

These HL7 components have to be used to specify the patient ID as well as alternate patient ID of the patient addressed by the HL7 PID segment. The specification of the patient ID is mandatory, whereas the specification of an alternate patient ID is optional. To differentiate between the two IDs, the HL7 component PID-3.5 has to specify one of the following values:

- PI or PN: Used when PID-3.1 specifies the patient ID.
- NH, NI, or SS: Used when PID-3.1 specifies an alternate patient ID.
 - NI indicates that the alternate patient ID represents a unique national identifier.
 - NH indicates that the alternate patient ID represents a national health service number.
 - SS indicates that the alternate patient ID represents a social security number.

If PID-3.5 contains the value GPI, PID-3.1 contains the XAD-PID, and all patient IDs of the message are linked with this XAD-PID.

PID-3.4

This HL7 component defines the Assigning Authority of the patient ID and alternate patient ID. For the patient ID, the Assigning Authority should be specified if it differs from the default Authority of the site. Otherwise the default Authority is used. For the alternate patient ID, one of the following HL7 subcomponents is evaluated:

- PID-3.4.1 is evaluated if it is specified.
- PID-3.4.2 is used if PID-3.4.1 has been left empty.

■ PID-5.1 to PID-5.8

These HL7 components are evaluated to obtain the names of the patient. If PID-5.7 contains a B, the repetition specifies the birth name. Otherwise, *syngo.share* assumes that the specified name is the legal name; this could also be indicated by the value L. Because *syngo.share* is able to store the alphabetic, ideographic, and phonetic name of a patient, the HL7 component PID-5.8 has to specify one of the following:

- A for alphabetic,
- I for ideographic,
- P for phonetic.

3.8.3 HL7 MRG Segment

■ MRG-1.1

If an HL7 MRG segment is used to merge a patient, the MRG-1.1 HL7 component has to define the patient ID of the patient that is to be invalidated.

■ MRG-1.4

The Assigning Authority of the prior patient ID has to be defined by the HL7 component MRG-1.4 if it differs from the default Authority of the site. Otherwise, the default Authority is used.

■ MRG-1.5

This HL7 component has to specify the value PI or PN to ensure that *syngo.share* detects the patient ID.

■ MRG-5.1

If an HL7 MRG segment is used to move or merge a visit, the HL7 component MRG-5.1 has to specify the visit ID of the visit that is to be moved or invalidated.

■ MRG-5.4

The Assigning Authority of the prior visit ID has to be defined by the HL7 component MRG-5.4 if it differs from the default Authority of the site. Otherwise the default Authority is used.

¶ PV1-1

This HL7 field should specify the value 1. Note that *syngo.share* cannot process more than one HL7 PV1 segment.

¶ PV1-2

If the PV1 segment is present in the HL7 message but not required for the given HL7 message type, the value N (Not Applicable) can be used to transfer a PV1 segment without a visit ID.

¶ PV1-9

This HL7 field should not be defined. Rather, an HL7 ROL segment should be added to the HL7 message to specify the consulting doctor.

Nevertheless, if the consulting doctor is defined by the HL7 field PV1-9 but not by an HL7 ROL segment, the HL7 field PV1-9 is evaluated.

■ ORC-1

❏ OBR-1

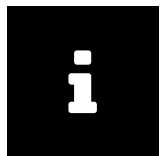

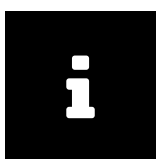

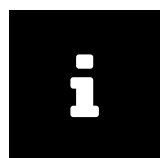

4 HL7 Outbound Interface

4.1 Routing of Generic Files

4.1.1 Operating Mode

In some workflows, it might be necessary to route generic files that have been archived by *syngo.share* to third-party systems. To make use of this feature, an action of the type *GenericRouter* has to be configured (see the *syngo.share* core Online Help for more information).

Once a *GenericRouter* has been created, it automatically routes generic files via HL7 MDM messages to a configured third-party system. If an already routed generic file is modified, the routing is repeated to ensure that the receiving third-party system is up to date.

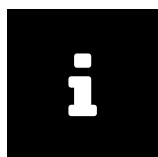
4.1.1.1 Transmission

In general, all types of generic files can be routed. Each HL7 MDM message is dedicated to exactly one generic file. The binary data of a generic file is transmitted either by reference or by value:

- If the binary data is transmitted by reference, the generic file is written to a share and referenced by a UNC path which adheres to the following format:
 - Windows: \\<host>\<share>\<path>
 - Linux: //<host>/<share>/<path>
- If the binary data is transmitted by value, it is encapsulated in the HL7 MDM message. Since it is not allowed to transmit non-printable characters within an HL7 message, *syngo.share* encodes binary data as a Base64 string.

4.1.1.2 Identification

To ensure that the receiving third-party system can uniquely identify a generic file, *syngo.share* specifies two IDs: a generic file ID and an application ID. The application ID is defined to ensure that the receiving third-party system can uniquely identify *syngo.share*, whereas the generic file ID is stated to allow the third-party system to identify the generic file among the routed generic files.



Note

These IDs are not identical with the original IDs used by *syngo.share* to identify the generic file.

Each generic file is archived in *syngo.share* within a so-called generic container. *syngo.share* uses these generic containers to group generic files. The containers are identified by a generic container ID and a coding system ID. For routing, *syngo.share* uses the generic container ID and coding system ID to inform the third-party system about the container to which the routed generic file belongs.

Since generic containers might be reused for patients and shared between third-party systems, the combination of generic container ID and coding system ID needs to be unique. However, to ensure that generic containers can be used in a meaningful way, *syngo.share* ensures that a patient does not possess two generic containers with identical generic container ID and coding system ID related to a particular visit and Organizational Unit.

4.1.1.3 Routing Events

In general, *syngo.share* routes a generic file when one of the following events occurs:

- Import, undeletion or update (metadata or binary data) of a generic file
- Update of a patient associated with a generic file
- Change of a patient associated with a generic file from non-HL7-managed to HL7-managed
- Update of a visit associated with a generic file
- Change of the Organizational Unit of a document associated with a generic file
- Change of the workflow state of a document associated with a generic file
- Change of the visibility restriction type of a generic file

4.1.2 HL7 MDM Message Structure

4.1.2.1 HL7 Trigger Events

To route generic files via HL7 MDM messages, *syngo.share* uses the trigger event T02 as proposed by the HL7 Messaging Standard.

The transmitted HL7 MDM messages adhere to the following structure:

MSH PID [PV1] {[ORC] OBR} TXA {OBX}

4.1.2.2 HL7 Elements

TXA-12.1

This HL7 component specifies the generic file ID.

MSH-3.1

This HL7 component specifies the application ID.

OBX-3.1 and OBX-3.3

These HL7 components are used to define the original generic file ID and the original application ID. However, according to the HL7 Messaging Standard, they should not be used to identify the routed generic file.

OBX-3.4 and OBX-3.6

These HL7 components identify the original generic container.

TXA-24.1 and TXA-24.3

These HL7 components specify the generic container ID and the coding system ID.

PV1 and ORC

These segments are present if and only if the underlying generic file consists of visit and order information.

ORC and OBR

DICOM studies linked by their Accession Number and/or the Requested Procedure ID are specified by additional ORC and OBR segment pairs.

OBX

DICOM studies linked by their Study Instance UID are specified by additional OBX segments.

4.2 Referencing of DICOM Studies and Generic Containers

4.2.1 Operating Mode

In *syngo.share*, a reference pointer is a string which refers either to a DICOM study or to a generic container. It can be used by third-party systems (e.g., HIS, RIS) to access, share, or delete a DICOM study or generic container without holding the actual data. To this end, the URL interface of the component view has to be called (see Interface and Integration Manual).

To send reference pointers, an action of the type `ReferencePointerNotifier` has to be configured (see the *syngo.share* core Online Help for more information). Once a `ReferencePointerNotifier` has been created, it automatically sends reference pointers via HL7 ORU messages to a configured third-party system.

4.2.1.1 Transmission

Each HL7 ORU message is dedicated to exactly one reference pointer. If a DICOM study or generic container is modified in such a way that the changes influence the operational reliability of a previously sent reference pointer (for example, when a DICOM study or generic container is deleted), *syngo.share* informs the third-party system about those changes.

To this end, *syngo.share* transmits an HL7 ORU message which either updates or deletes the affected reference pointer. Note that there is no difference between HL7 ORU messages which insert reference pointers and HL7 ORU messages which update existing reference pointers.

If a third-party system cannot deal with HL7 ORU messages which update reference pointers, *syngo.share* offers the possibility to delete reference pointers before they are updated. In this case, *syngo.share* first sends an HL7 ORU message which deletes a reference pointer before it transmits the actual HL7 ORU message that updates the affected reference pointer.

The HL7 ORU message is not sent if the Authorities contained therein conflict with the Assigning Authority settings of the receiving application. Further details about reference pointers can be found in the *syngo.share* core Online Help.

4.2.1.2 Reference Pointer Events

In general, *syngo.share* inserts, updates, or deletes a reference pointer if one of the following events occurs:

- Import, deletion, undeletion or update (metadata or binary data) of a DICOM study or generic container
- Import, deletion or undeletion of a DICOM image or generic file (resulting in a change to the number of instances of the corresponding DICOM study or generic container)
- Keyword changes to a DICOM study or generic container
- Change of the composition of a DICOM study (i.e. the modalities of the DICOM series) or generic container (i.e. the file extensions of all associated generic files)
- Change of the Organizational Unit of a DICOM study or generic container
- Update of a patient associated with a DICOM study or generic container
- Change of a patient associated with a DICOM study or generic container from non-HL7-managed to HL7-managed
- Update of a visit associated with a DICOM study or generic container

In addition, reference pointers are also deleted when their DICOM studies or generic containers no longer satisfy the conditions specified by the configured `ReferencePointerNotifier`.

4.2.2 HL7 ORU Message Structure

4.2.2.1 HL7 Trigger Events

To insert, update, and delete reference pointers via HL7 ORU messages, *syngo.share* uses the trigger event R01. The transmitted HL7 ORU messages exhibit the following structure:

4.2.2.2 HL7 Elements

■ OBR and ORC

If the DICOM study, generic container, or generic file is not associated with an order, only **OBR** is given. Otherwise, the pair **ORC** and **OBR** is given per associated order. For a generic container or generic file, this can be multiple times.

■ OBR-25 and OBX-11

These HL7 fields are used to distinguish between HL7 ORU messages which insert or update reference pointers and HL7 ORU messages which delete reference pointers by setting one of the following values:

- F: This value is specified when inserting and updating reference pointers
- D: This value is specified when deleting reference pointers.

■ PV1 and ORC

These HL7 segments are present if and only if the underlying document consists of visit or order information.

4.3 Query Messages

4.3.1 Operating Mode

The *ScanImportServer* component of *syngo.share*, which is designed to import PDF files generated by a mass scanning device, uses data from a generated index file to map an imported PDF file to a patient/visit combination known to *syngo.share*.

If the patient/visit combination is not known to *syngo.share* or the data read from the index file is not sufficient, an HL7 QRY message can be configured to be sent to a third-party system, typically a HIS or RIS.

The response messages are not evaluated directly by *syngo.share* but can be forwarded to an arbitrary third-party system.

4.3.2 HL7 QRY Message Structure

syngo.share uses original mode HL7 QRY messages. The supported trigger events of HL7 QRY are A19, indicating that an HL7 ADR response is expected, and Q01, indicating that an HL7 DSR response is expected.

The messages therefore exhibit the following structure:

4.4 Acknowledgment of Processed HL7 Messages

4.4.1 Operating Mode

If HL7 messages are received by *syngo.share* according to the enhanced processing rules, it might be necessary to exchange further information regarding the processing of these HL7 messages via so-called HL7 application acknowledgment messages.

To this end, an action of the type `HL7MessageProcessingNotifier` has to be configured (see *syngo.share* core Online Help for more information). Once an `HL7MessageProcessingNotifier` has been created, an HL7 application acknowledgment message is automatically transmitted as soon as an HL7 message which requires the exchange of further information has been processed.

syngo.share is able to generate and transmit HL7 application acknowledgment messages for all processable HL7 messages. Each HL7 application acknowledgment message is dedicated to exactly one HL7 message and specifies the processing status. The control ID of the initial HL7 message is specified in order to ensure that a third-party system knows which HL7 message has been acknowledged.

4.4.1.1 Application Acknowledgment Message Events

In general, an HL7 application acknowledgment message is transmitted when the following event occurs:

- Processing of an HL7 message

4.4.1.2 Special Conditions

The application acknowledgment type specified in the original HL7 message (see HL7 field MSH-16) must be compatible with its processing status:

- SU: If the original HL7 message specifies the application acknowledgment type SU, an HL7 application acknowledgment message is sent if and only if the processing of the HL7 message succeeded.
- ER: If the original HL7 message specifies the application acknowledgment type ER, an HL7 application acknowledgment message is sent if and only if the processing of the HL7 message failed.
- AL: If the original HL7 message specifies the application acknowledgment type AL, an HL7 application acknowledgment message is sent regardless of whether the processing of the HL7 message succeeded or failed.

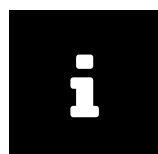

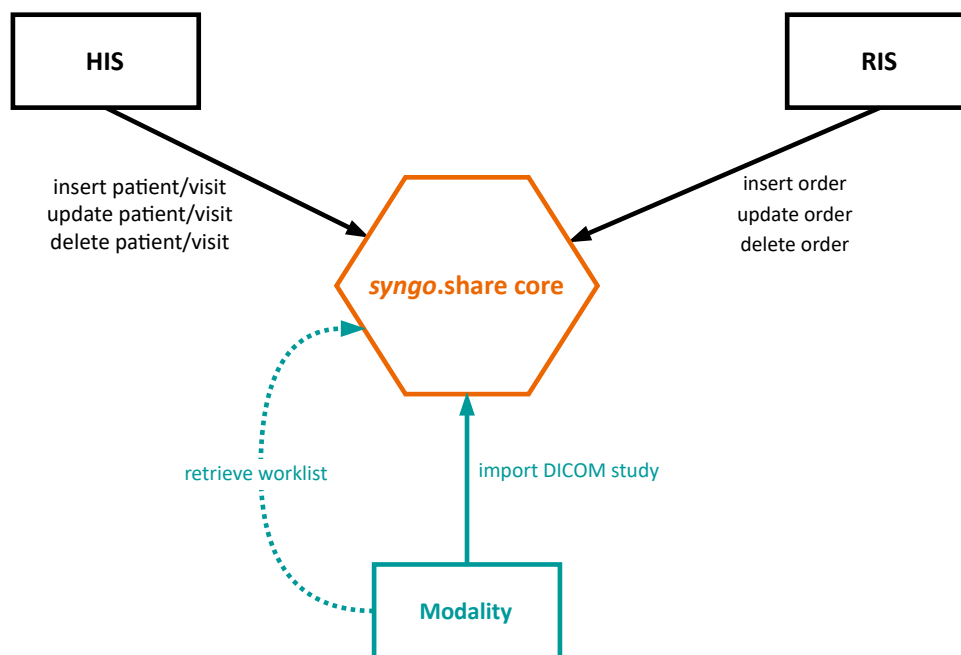

A HL7 Example Workflows

A.1 Ordering of DICOM Studies

One of the major tasks of *syngo.share* is the archiving of DICOM images. To guarantee the integrity and consistency of the stored DICOM images, *syngo.share* fulfills all requirements of the following IHE profiles: Scheduled Workflow, Patient Information Reconciliation, and Scheduled Workflow.b. In this context, the HL7 inbound interface is responsible for a correct and continuous update and propagation of patient, visit, and order information, as illustrated in [Figure 1](#).

Figure 1: Ordering Workflow



To ensure that stored patient and visit information is up to date, *syngo.share* receives HL7 ADT messages. To ensure that the ordering information of DICOM images is updated and DICOM images are associated with the intended patients, *syngo.share* receives HL7 OMI or HL7 ORM messages. Usually, patients and visits are administrated by an HIS, whereas orders are managed by a RIS. To allow for the fine-grained modification of patient, visit and order information, *syngo.share* supports various kinds of HL7 ADT, HL7 OMI, and HL7 ORM messages.

The following sections show HL7 sample messages for a typical patient encounter which involves the registration of a patient, the placement of an order, as well as the update and deletion of order, visit, and patient information.

A.1.1 Patient Registration

If a patient arrives at a healthcare facility, the personal data of the patient is stored and forwarded to *syngo.share*. To this end, an HL7 ADT A04 message similar to the one shown in [Example 7](#) is sent to *syngo.share*.

A.1.2 Order Placement

A.1.3 Order Updates

Once placed, the order is processed by a modality which sends the created DICOM images to *syngo.share*. If that order information changes during the creation of the DICOM images or after the completion of the order, the RIS updates the transmitted order information by sending an HL7 OMI O23 or HL7 ORM O01 message as shown in Examples 10 and 11.

To ensure that the order information of the archived DICOM images (Accession Number, referring physician, DICOM study description, and Requested Procedure ID) are updated by *syngo.share* too, the metadata update has to be activated.

A.1.4 Correction of Patient and Visit Information

During the further medication of the patient it might happen that patient and visit information are completed or corrected. If personal data is modified, the HIS informs *syngo.share* about the changes made by sending an HL7 ADT A08 message similar to the one shown in Example 12.

If the identification of the patient or visit changes for one of the following reasons, the HIS sends a corresponding message to *syngo.share*:

- The patient ID is replaced by another patient ID. The HIS sends an HL7 ADT A47 message as shown in Example 13.
- The visit ID is replaced by another visit ID. The HIS sends an HL7 ADT A50 message as shown in Example 14.
- The visit is moved to another patient. The HIS sends an HL7 ADT A45 message as shown in Example 15.
- The patient is merged with another patient. The HIS sends an HL7 ADT A40 message as shown in Example 16.
- The visit is merged with another visit. The HIS sends an HL7 ADT A42 message as shown in Example 17.

Note that all these changes also affect the metadata of the DICOM images which are associated with the altered patient and visit.

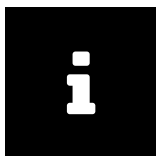

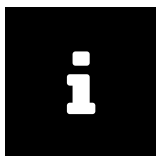

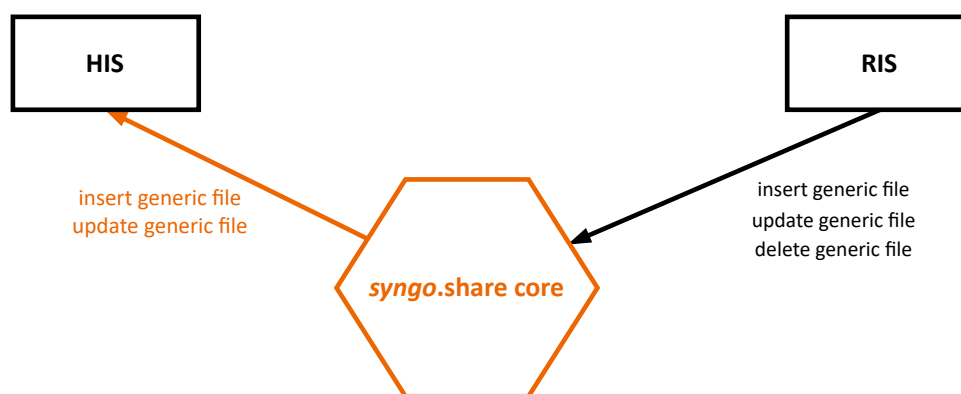

A.2 Archiving of Generic Files

The HL7 interface is one of the most frequently used interfaces for handling generic files. *syngo.share* supports various kinds of HL7 MDM and HL7 ORU messages that are used to insert, update, and delete generic files. If generic files are routed to third-party systems, *syngo.share* guarantees that updates are relayed by sending adequate HL7 MDM messages. The archiving workflow of generic files is illustrated in Figure 2.

Figure 2: Generic File Archiving Workflow



The following sections show HL7 sample messages for a typical patient encounter which reflects the creation, routing, update and deletion of a report. They concern HL7 MDM and HL7 ORU messages used by third-party systems to insert, update, and delete generic files as well as the HL7 MDM messages used by *syngo.share* to route and synchronize generic files.

A.2.1 Insertion of a Generic File

Assume that a patient has arrived at a healthcare facility, the personal data of the patient has been stored and forwarded to *syngo.share*, and an order has been scheduled by the RIS, relayed to *syngo.share*, and performed by a modality in order to be able to proceed with the patient's treatment.

Next, the DICOM study is analyzed by a radiologist, who creates a report. The RIS sends this report to *syngo.share* via HL7 MDM T02 or HL7 ORU R01 message to ensure that it is archived; see Examples 22 and 23, as well as Examples 24 and 25.

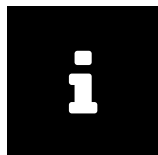

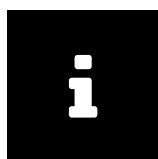

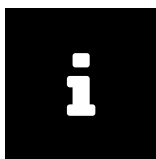

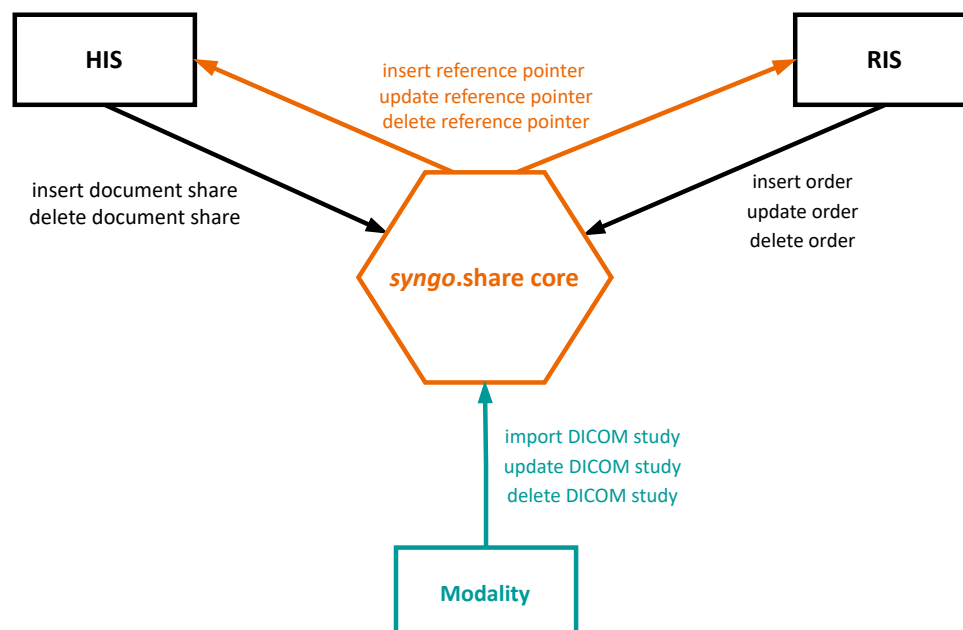
A.3 Referencing of DICOM Studies and Generic Containers

Some of the most frequently used methods for accessing, sharing, and deleting DICOM studies and generic containers are based on reference pointers. To ensure that third-party systems can use these methods to meet their requirements, *syngo.share* automatically transmits reference pointers to third-party systems via HL7 ORU messages.

Since the modification of DICOM studies and generic containers might influence the operational reliability of reference pointers, *syngo.share* updates and deletes reference pointers automatically by trans-

mitting appropriate HL7 ORU messages. The functionalities based on reference pointers are illustrated in [Figure 3](#).

Figure 3: Reference Pointer Workflow



The following sections shows HL7 ORU sample messages for a typical patient encounter. The examples cover HL7 ORU messages which are used by third-party systems to share and delete DICOM studies and generic containers, as well as HL7 ORU messages used by *syngo.share* to transmit and synchronize reference pointers during the creation, update, sharing and deletion of a DICOM study and report.

A.3.1 Creation of a Reference Pointer (DICOM Study)

The following scenario assumes that a patient has arrived at a healthcare facility, their personal data has been stored and forwarded to *syngo.share*, and an order has been scheduled by the RIS and transmitted to *syngo.share* in order to proceed with the patient's treatment.

This order is then processed by a modality which sends the created DICOM images to *syngo.share*. As soon as all DICOM images have been archived, a reference pointer addressing the corresponding DICOM study is sent to the dedicated third-party systems, in this particular example the HIS and RIS, via HL7 ORU R01 messages similar to the one shown in [Example 35](#).

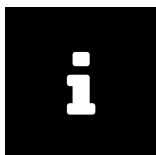
Afterwards, the DICOM study is analyzed by a radiologist. During the appraisal, the radiologist realizes that some metadata of the created DICOM study are incorrect. To correct these mistakes, the RIS updates the performed order and thus the corresponding DICOM study by sending an appropriate HL7 message. To ensure that *syngo.share* updates the order information of the DICOM study, the metadata update has to be activated.

Once the metadata update is complete, the previously inserted reference pointer is updated via HL7 ORU R01 message, as shown in Example 36.
