

Privacy Notice for Registration and/or Participation in Siemens Healthineers Events/Conference in Thailand

Protecting the security and privacy of Personal data of persons registering and/or participating our events (each an “Event Participant”) is important to Siemens Healthineers AG and its affiliated companies, which in Thailand, is **Siemens Healthcare Limited, Charn Issara Tower II, 26 Fl. 2922/292 New Petchburi Rd. Bangkok, Huaykwang, Bangkok 10310, Thailand** (“Siemens Healthineers”). Siemens Healthineers processes personal data in compliance with applicable law on data protection and security, which in Thailand is Personal Data Protection Act (2019) and its implementing rules and regulations. The following privacy notice explains how Siemens Healthineers processes your personal data and describes your related rights.

Categories of personal data processed, purpose of the processing and legal basis

In the context of an Event Participant registering to attend and/or participating in our events, we may process personal data for the following purposes:

- Communicating with Event Participant about products, services and projects of Siemens Healthineers or Event Participants, e.g. by responding to inquiries or requests;
- Planning, organization and implementation of current and future events including the provision of services and requests such as hotel bookings, travel, logistics, etc;
- Administrating and performing customer surveys, marketing campaigns, market analysis, sweepstakes, contests, or other promotional activities or events;
- Maintaining and protecting the security of our events and websites used for registration in our events, preventing and detecting security threats, fraud or other criminal or malicious activities;
- Ensuring compliance with legal obligations (such as record keeping obligations) to comply with reportorial requirements;
- Meeting legal and statutory requirements; and
- Other purposes directly relating to the above.

For the aforementioned purposes, Siemens Healthineers may process the following categories of personal data:

- Contact information, such as full name, work address, work telephone number, work mobile phone number, work fax number and work email address;
- If the event charges any fee: payment data, such as data necessary for processing payment and fraud prevention, including credit/debit card numbers, security code numbers and other related billing information; and
- Photo and camera audio and/or visual recordings which may determine identity, actions and/or whereabouts.

The processing of personal data is necessary to meet the aforementioned. Unless indicated otherwise, the legal basis for the processing of personal data is Sections 23 and 24(1)-(6) of the Personal Data Protection Act 2019 or – if explicitly provided by Event Participant – the consent (Sections 19, of Personal Data Protection Act 2019).

If the personal data mentioned are not made available or Siemens Healthineers cannot collect them, the individual purposes described may not be achieved.

Transfer and disclosure of personal data

Siemens Healthineers may transfer or disclosure personal data to the following but only if and to the extent such transfer is strictly required for the purposes mentioned above:

- Siemens Healthineers affiliates (which may be located within or outside Thailand) and
- Service providers which process personal data as part of their service provision for Siemens Healthineers (e.g., event and travel agencies).

Specifically with respect to personal data being photo and camera audio and/or visual recordings, Siemens Healthineers may also transfer or disclose to the public and third parties strictly for the purpose of marketing campaigns and promotional activities through social media platforms in the internet, including but not limited to , Facebook, Google+, YouTube, LinkedIn, Twitter, Xing and further social media platforms that may become relevant for the purpose of corporate communication; the press; and broadcasting organizations, according to their respective terms of use and data privacy policy.

If legally permitted to do so, Siemens Healthineers may transfer personal data to courts, law enforcement authorities, regulators or attorney if necessary to comply with the law or for the establishment, exercise or defense of legal claims.

Siemens Healthineers commission service providers (so-called data processors), such as hosting or IT maintenance service providers, which only act upon instructions of Siemens Healthineers and are contractually bound to act in compliance with applicable data protection law.

Recipients of personal data may possibly be located in countries outside of the Thailand, in which applicable laws do not offer the same level of data protection as the laws of the Thailand. In such cases and unless permitted otherwise by applicable law, Siemens Healthineers takes measures to implement appropriate and suitable safeguards for the protection of personal data through use of contractual or by other reasonable means to provide a comparable level of protection.

Retention period

Unless explicitly indicated otherwise at the time of the collection of the Event Participant `s personal data (e.g. within a consent form accepted by the Event Participant), we erase personal data if the retention of the personal data is no longer necessary in relation to the purposes for which they were collected or otherwise processed and no statutory retention obligations under applicable law require us to further retain personal data.

Unless otherwise legally restricted, an exception is made for photos and video that have a historical value and are permanently archived for use in future historical publications, such as publications on company history.

Right to withdraw consent

In case an Event Participant declared his/her consent for the processing of certain personal data by Siemens Healthineers, the Event Participant act has the right to withdraw the consent at any time with future effect, i.e. the withdrawal of the consent does not affect the lawfulness of processing based on the consent before its withdrawal. In case consent is withdrawn, Siemens Healthineers may only further process the personal data where there is another legal ground for the processing.

Right of access to and rectification or erasure of personal data, restriction of processing, right to object to processing and right to data portability

Under applicable data protection law and affected Event Participant may – provided that the respective legal pre-conditions are met – have the right to:

- obtain from Siemens Healthineers confirmation as to whether or not personal data concerning the Event Participant are being processed, and where that is the case, access to a copy of the personal data;
- obtain from Siemens Healthineers the rectification of inaccurate personal data;
- obtain from Siemens Healthineers the erasure of the Event Participant's personal data;
- obtain from Siemens Healthineers restriction of processing regarding the Event Participant's personal data;
- data portability concerning Event Participant's personal data, which has been actively provided; and
- object, on grounds relating to the Event Participant's particular situation, to processing of personal data concerning you unless, in some circumstances, we are required by law to keep it. You also have the right to make a complaint to the data protection supervisory authority.
